Dues Payment Policy: Each member family shall have paid at least one-half of their annual dues and the full tuition for all their children in Religious School by the High Holy Days, and the balance by December 15th, unless other appropriate arrangements have been made through the Temple Administrator or the Dues Arrangements Committee.

If at all possible, full payment would be very helpful and appreciated. In all cases, all financial obligations to the Temple must be met by the end of the fiscal year for the member family to remain a Member in Good Standing under Article V of the Constitution. The membership cost listed above is the discounted cash price. Additional charges of 2½% apply should you wish to pay by credit or debit card.
